# MINUTES OF THE MEETING OF WICKHAM ST PAULS PARISH COUNCIL HELD ON TUESDAY 25<sup>th</sup> September 2018, AT 7.30pm IN THE PAVILLION, OF THE VILLAGE HALL

### 18/114 Welcome and Apologies for Absence.

Chairman welcomed everyone, apologies for absence received from Cllr. P. Nuttall and County Cllr. David Finch.

## 18/115 Declaration of Interests.

None.

18/116 Public Participation Session with respect to items on the agenda and other matters that are of mutual interest. A member of the public spoke about item 18/128 and reminded councillors that the village green cannot be

closed off, as it is a recreation area. Chairman confirmed that the village green will not be closed off and that there would only be around four areas, each approximately  $2m^2$ . A comment was made that the pond is fed by natural springs. Several members of the public raised issues regarding item 18/134, as to why is the Herrington Trust selling land that it should have been donated to the village, questions as to whether the lease can be transferred over, where have the proceeds over the years gone and was it shared out and given to the less well-off residents within the village. District Cllr. Wendy Scattergood commented that similar trusts used revenues to support residents in various ways. A comment was made of what the Charities Commission constitute as a 'poor' person and that it could be interpreted as to be a general support of residents. A member of the public raised the issue that the bus shelter in Church Road is covered with overgrowth, the 30mph signs are also covered, and the triangle at Catley Cross junction is overgrown. The dog sack dispenser outside the village hall is empty.

District Cllr. Wendy Scattergood updated members that Councils are looking at budgets. Under item 18/127 on the agenda regarding additional parking, further measurements need to be obtained before her support can be granted.

Shortfall to be made up by the Parish Council, if more funds received then required, then they are to be donated to The Royal British Legion.
