Other matters not affecting our opinion which we draw to the attention of the authority:
In the prior year, the smaller authority was exempt from our review, thus we have not reviewed any evidence to support the prior year comparatives on the AGAR.
The smaller authority has not provided an adequate explanation for the variance between the prior and current year values in Box 3 and Box 6 of Section 2.
The smaller authority should ensure that it has regard to the level of reserves held when considering future precept requests.
